ADMITTING THE WINES TO THE CONTEST:

The International Wine Contest Bucharest 2013 is open to all categories and types of wines, as defined in the "International Code of Oenological Practices", which were produced in compliance with the legislation of the country of origin. Other special wines or grape-based products, must or wine, as well as spirituous beverages of vitivinicultural origin will be admitted to the Contest.

The wines and other vitivinicultural products presented to the jury will be grouped in categories, according to the OIV regulation, being presented in ANNEX I.

Each wine sample or each vitivinicultural product sample submitted to the Contest will consist of

- **4 bottles of 0.75 liters each** (in certain cases, 0.5 liters and 1 liter bottles will also be accepted) or
- **3 bottles of 1.5 liters or 2 liters each**

The wines must be personalized with their original label, complying with the legislation of the country of origin.

REGISTRATION METHOD:

Each wine or vitivinicultural product shall be accompanied by a **Wine registration form**, which shall contain at least the following information:

- Grape variety or varieties (indicating the percentage in which they appear in the wine);
- The exact name of the product in compliance with the legislation of the country of origin;
- Vintage (if applicable);
- Color
- The category of the product in accordance with Annex 1;
- The maturation of the wine in contact with wood (if applicable).
- The available commercial quantity of wine corresponding to the sample submitted to the Contest. This volume must be available in a minimum quantity of 1000 liters. In certain cases, when the production of a certain wine is extremely limited (wines of botrytis grapes, ice wines etc.) such volumes may be of not less than 100 liters;
- Technical data;
- The authorized person's name and signature.

This registration form must be enclosed in the same box as the wine sample bottles, together with **two labels** (front label and back label of the bottle)for each sample of wine.

Each participant must submit to the organizers (by mail) the **Participant registration form** for the registered samples, accompanied by the **proof of payment** of the registration fee.

This form shall be sent to the organizers via:

Participant registration form shall contain the following information:

- The participant's identity;
- The technical manager's name (optional);
- The list of all the wines submitted in the contest;
- Information regarding the submission of the samples and the acceptance of their participation;
- The authorized person's name and signature and the company's seal.

Failure to comply with the registration deadline and payment of fees will result in the impossibility of taking part in the contest.

In case of shipping via plane, the note accompanying the box shall have the “accounting information” field filled in as follows: **FREE HOUSE DELIVERY** (included excises and taxes).

The reception of the samples requires the **registration forms** and the **proof of payment** of the registration fee. The wine samples received without registration or not complying with the registration criteria will not be returned and will remain in the organizers' possession. The wines accepted for the contest will also remain in the organizers' possession.

The deadline for reception of samples is May 10th, 2013.

The sample reception will take place from Monday to Friday, between 9 a.m. – 4 p.m.
